The meeting was informal and these notes capture the key aspects of our discussions. Shirley Williams was welcomed to the meeting.

Elise recapped on the key points from the last meeting; the notes from the meeting had been shared prior to the meeting.

Elise reminded the meeting about NAPP, The National Association for Patient Participation and suggested that PPG members take a look at the web site especially the members section. The Clinical Commissioning Group has paid for membership for all GP practices in the Locality the members log in xxxxxx will enable you to access the member section. NAPP is an excellent resource for PPGs and provides a wealth of information about the work of other groups.
